# SELECTMEN'S AUTHORITY

# March 16, 1990 Town Meeting - Passed

To see if the Town will vote to adopt the provisions of RSA 41 :9-a allowing the Selectmen to set, and from time to time, review and correct fees charged.

## March 10, 1994 Town Meeting - Passed

To see if the Town will vote to accept the provisions of RSA 31:95-bproviding that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the Selectmen to apply for, accept and expend, without further action by the Town Meeting, unanticipated money from a state, federal, or other governmental unit or a private source which becomes available during the fiscal year.

## March 16, 1995 Town Meeting - Passed

To see if the Town will vote to accept the provisions of RSA 674:40-a providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, authorize the Board of Selectmen to accept the dedication of any street shown on a subdivision plat approved by the Planning Board, provided that such street has been constructed to applicable Town specifications as determined by the Board of Selectmen or their agent.

#### March 12, 2002 Election Results - Passed

As permitted by RSA 414-c, to see if the Town will vote to adopt the provisions of RSA 41: 14-a that will grant the Selectmen the authority to acquire or sell land, buildings, or both; provided, however, they shall first submit any such proposed acquisition or sale to both the Planning Board and to the Conservation Commission for review and recommendation by those bodies, and after recommendations from both bodies, they shall hold two public hearings in accordance with RSA 41: 14-1.

#### March 11, 2003 Election Results - Passed

To see if the Town will vote to adopt the provisions of RSA 149:I (Relating to Sewers) to provide the Board of Selectmen with the authority contained therein including the authority to assess upon the persons whose lands benefit from the Baboosic Lake Community Septic System their just share of the expense of constructing and maintaining the same or paying off any capital debt or interest incurred in constructing and/or maintaining the same.

# March 11, 2003 Election Results - Passed

To see if the Town will authorize the Board of Selectmen to appoint a capital improvement program (CIP) committee pursuant to RSA 674:5, consisting of at least one member of the Planning Board and include, but not limited to other members of the Planning Board, the Ways & Means Committee, or the Board of Selectmen, to prepare and amend a recommended program of municipal capital improvement projects projected over a period of at least six years. The sole purpose and effect of the capital improvements program shall be to aid the Selectmen and the Ways & Means Committee in their consideration of the annual budget per RSA 674:5.

## March 14, 2006 Election Results - Passed

To see whether, in accordance with RSA 80:80 (III), the Town will authorize the Selectmen to convey property received by tax deed on such conditions and terms as they, in their judgment, deem that justice may require, and that said authority, pursuant to RSA 80:80 (IV), shall continue in effect indefinitely until expressly rescinded.
