17	within the M.O.U. that the Cemetery Trustee would be charged the expense amount for the
18	fiscal year, less the Tomb and Burial fees collected. Finance Department will be notified.
19	It is also agreed on that the expected revenue will entered into the budget.

21	Forestview Cemetery review:
22	There is no additional information from Meridian at this point. Mike Riccittelli is waiting for
23	information on the design. Eric Hahn will go and talk with Meridian.
24	Discussion follows regarding a resident meeting, sending out a bid document and meeting with
25	Meridian.

27	<u>General:</u> Gertrude Martin has passed away and currently there are 2 grave stones on a three
28	grave lot, the family is requesting that they be allowed to place a third stone. Lisa states that
29	this is in prohibited and in the rules and regulations. Lisa makes a motion to prohibit the
30	placement of a third gravestone, seconded by Marie. All in favor, motion passes.

32	Marie received an email requesting that the state archaeologist Mark Doperalski would like to
33	use the Town of Amherst's photos obtained when the human remains were found under town
34	hall in 2002. All of the Cemetery Trustees agree to provide these photos to Mr. Doperlaski.

36	Marie has found able bodies to paint the rod iron fence at the cemeteries during April
37	vacation. The town will provide paint and brushes. Where there are no power tools involved
38	this does not need to be approved by the insurance.
