4	In attendance were: Marie Grella, Chairperson, Cynthia Dokmo, Lisa Eastland, Bruce Berry,
5	Cemetery Sexton, Pat Delisle, Executive Assistant, Mr. Roberts and Jacob Roberts.
6	Comology Sexton, I at Densie, Executive Assistant, 101. Recents and vacoo Recents.
7	The meeting was called to order by Marie Grella at 1:00 pm
8	
9	Citizens' Forum- There was no citizen comments.
10	
11	Eagle Scout Project: Jacob Roberts is working on his Eagle Scout Project. To Jacob the Eagle
12	Scout Project is a way of giving back to the community in the form of a service provided. Jacob
13	has chosen the cemetery to do his Eagle Scout Project because he has a lot of military in his
14	family. He had originally asked to construct a wooden bench, but a wooden bench would need to
15	be maintained and the Trustees would like something maintenance free. Marie would like to
16	suggest a "Memorial Garden" which is a similar to a scattering garden but the cremains are
17	buried, not scattered. Jacob will research current Memorial Gardens (size, landscaping, prices,
18	how others handle the record keeping for burials). This project would need to be approved by
19	several committees of the scouts (which could take some time), and would need to be completed
20	by November 2017. The Cemetery Trustees will meet again on March 30 th to discuss the
21	research done at that point.
22	Mr. Roberts and Jacob Roberts left the meeting.

24	The Cemetery Trustees discussed differently Memorial Gardens and scatter gardens. Lisa
25	Eastland made a motion to establish a "Memorial Garden" in Meadowview Cemetery, seconded
26	by Cynthia Dokmo, all in favor, motion passes.
27	Minutes. Maria makes a mation to annous the Eakmany 22, 2017 masting minutes, accorded
28	Minutes: Marie makes a motion to approve the February 23, 2017 meeting minutes, seconded
29	by Cynthia all in favor, motion passes.
30 31	Discussion follows regarding, Forestview Cemetery and having it surveyed. Research will be done to see
32	if there has been a survey completed for this property, if so, one will not need to be done.
33	Cynthia makes a motion to adjourn at 2:30, seconded by Marie, all in favor, meeting adjourned.
34	Cynuna makes a motion to adjourn at 2.50, seconded by Marie, an in ravor, meeting adjourned.
35	Letters of authorization to the Trustees of the Trust Fund are generated and signed. One letter
36	will pay $G2+1$, LLC in the amount of \$826.58 from the Forestview Cemetery Design Fund.
37	Another letter will authorize the Trustees of the Trust Fund to pay 21,477.65 to the Town of
38	Amherst for FY16 maintenance of the cemeteries.
