***Administrative Reports***

**Minutes**

- Amendments to meeting minutes from 9-14-16 should include:
  - 3<sup>rd</sup> bullet under Meadows/Forests/Invasives should read: “Logging has been completed at Haseltine, but there remains one load of logs to be picked up by the logger. It is located at the lower entrance on Austin Road.”
  - 2<sup>nd</sup> bullet under Infrastructure should read: “Frank cut metal...”
- J. Harvey moved to accept minutes with revisions, L. Gilman seconded, minutes are accepted as amended (amendments noted and to be sent to Jessica Marchant by J. Hardner)

***Management Areas***

**Water Resources**

- Paul Indeglia and R. Clemens will meet next week to discuss a proposed Amherst hydrology study and possible funding sources. R. Clemens expects to provide ACC with a fuller progress update at the next meeting.

**Meadows**

- L. Gilman says he’s looking into access to lower Joppa Hill from Horace Greeley by shoring up bridge.

### **Trails**

- J. Hardner presented a plan to rehabilitate and re-reroute trails at Haseltine (see attached ppt).
- Bill Stoughton, former Haseltine Steward, property neighbor, and frequent user of the area (hiker) spoke in favor of J. Hardner's trail proposal.
- R. Clemens requested that under the new design, consideration be given for connections that will allow users to bail out of long segments if they desire. J. Hardner pointed out a location where this could be accommodated using existing trail segments as spurs to other trails.
- B. Beckley stated a personal preference to avoid overly twisty trail designs for new re-routes, and cautioned to avoid blazing where it is visible from other trails to avoid users cutting between trails. He also stated that there should be latitude to modify the plan as needed to accommodate unexpected site-level issues during trail work.
- **L. Gilman motioned to approve J. Hardner's proposed plan to rehabilitate and re-route trails at Haseltine, and J. Harvey seconded. Vote: all in favor.**

### **Trail Infrastructure**

- Bill Stoughton, president of Greater Nashua Habitat for Humanity, described the recent volunteer initiative of Habitat for Humanity to build a new bridge at Joe English.
- ACC Commissioners expressed their gratitude for an excellent job completed.

### **Easements and Properties**

- L. Gilman visited and confirms encroachment of private driveway onto ACC property at 81 Broadway. Resolution in progress by D. D'Angelo.
- Boat also found abandoned on property. D. D'Angelo will contact Jim O'Mara regarding disposal.

### **Management Planning**

- J. Harvey reviewed with the Commission the purpose of an Amherst Conservation Plan.
- R. Clemens will take on gathering information regarding current wildlife monitoring in Amherst.
