HERITAGE COMMISSION

MEETING MINUTES

Town Hall – Landry Conference Room
Thursday, June 9, 2016 at 7:30 PM

I. **Call to Order:** Will Ludt called the meeting to order at 7:40 p.m. Members of the commission in attendance included Chairman Ludt, Carolyn Quinn, Larry McCoy, and Lisa Montesanto. Those absent included: Andy Ouellette, Mary Mahar, Bill Veillette, and Eric Hahn.

II. **Topics of Discussion**

a. “Throwback Thursday–Amherst Heritage”:

b. Farewell to Bill Veillette and Carolyn Quinn – Reflections of their AHC contributions.

Chairman Ludt said he hoped Bill Veillette could have made the meeting to reflect on all of the work he and Carolyn Quinn have done over the last 12-14 years while serving on the Heritage Commission. Chairman Ludt said he and Mr. Veillette co-founded the Heritage Commission and identified what the Commission could be for the town, and he wanted to pay homage to Bill for moving things along; developing rules and procedures. Mr. Veillette also worked on the Corn Crib Stabilization Program which was very important to the Heritage Commission. Bill did all the leg work in getting a DOT grant of \$340,000. Those funds helped to restore the Town Hall and remove the safety hazards. Bill was also instrumental in working on the Resource Survey and those were just a few items that came freely to Chairman Ludt’s mind.

Chairman Ludt became emotional when reflecting on his work with Carolyn Quinn. Both considered each other “best friends”. Chairman Ludt said one of the first celebrations that they worked together on was the 150th anniversary of the Brick School. Chairman Ludt recalled a neat celebration that included a historic impersonator, attendees sang Old Lang Syng. They had returning graduates and one woman who graduated from the Amherst High School in 1929 attended. A major project that Carolyn did an outstanding job on was the town’s 250th anniversary celebration which was a three or four year project in the making. It was a wonderful year long celebration in 2010 that started off with the reading of the document from the 1760 Governor Wentworth who

47 was appointed by the King of England. There was a ceremony at the church
48 and all organizations were invited to participate. From that, Carolyn was
49 chosen as Citizen of the Year. Chairman Ludt said he hated to see both
50 Carolyn and Bill go and it's too bad they are both leaving at the same time.
51 The Commission will need a good replacement and he thanked both Bill
52 Veillette and Carolyn Quinn for all they had done for the Heritage Commission
53 and their community.

55 To much laughter, Larry McCoy remembered living in the same neighborhood
56 as Carolyn and how he had hatched a plot to kidnap a neighbor's Irish Setter
57 and rid the neighborhood of the barking dog.

68 Commission members brought up names of residents who might serve on the
69 Heritage Commission to replace Bill Veillette and Carolyn Quinn. Chairman
70 Ludt mentioned Sarah Saskavitch who serves on the Nashua Regional
71 Planning Commission, had declined previously but is seriously thinking about
72 serving. Chairman Ludt will ask Sarah again if she is able to serve. Katrina
73 Holman has declined before. Mary Ireland, a teacher, and Liz Larson who is
74 very involved with the library were mentioned. Lisa Montesanto will reach out
75 to Liz Larson.

77 It was noted that Eric Hahn has not attended a meeting in some time. He
78 serves as the representative from the Planning Board. Commission members
79 discussed the importance of having a Planning Board representative on the
80 Heritage Commission. Chairman Ludt will speak with Arnie Rosenblatt,
81 Chair of the Planning Board, to get a replacement for Eric Hahn.

83 g. Updates from Other Boards and Commissions Attendance

85 Chairman Ludt said the NHDHR wants to come to Amherst in July or August
86 regarding the CLG. He will try to convince them that September would be
87 better after vacations are over and kids are back to school. They are looking
88 for an opportunity to discuss other things that could be done in Amherst
89 related to grant funding. They wish to meet with the Heritage Commission
90 and the Historic District Commission. Chairman Ludt will reach out to Jamie

91 Ramsey, Chair of the Historic District Commission. He said he prepares a
92 joint Annual Report for the state that Chairman Ramsey reviews.

94 The Bertha Rogers Grant Selection Committee stopped by to let Commission
95 members know that they had approved the grant to fund identifying and
96 cataloguing of materials in the town vault. The Committee members asked
97 that a plaque be included memorializing Bertha Rogers. The next step is the
98 Board of Selectmen approval prior to receipt of funds. The grant requesting
99 funds for the stone walls project was not approved. Larry McCoy suggested
100 getting one scenic road work done and that may help generate interest and
101 funding to complete the more of the scenic road work that is necessary. The
102 Commission may also want to explore designating Christian Hill as a scenic
103 road.
