Selectman Grella joined the meeting at 8:55 PM.

Discussion continued.

Selectman Grella moved to exit non-public session. Second by Selectman Lyon. The vote was unanimous 5-0.

The Board exited non-public session at 9:42 PM.


Chairman Brew stated that in non-public session no motions were made and no votes were taken.

Selectman Lyon moved to allow DPW employee, and soon to be deployed reservist, to receive differential pay while he is on active military leave. That the town pay Mr. Rochette the difference between his military base pay and his base pay he would have earned as a town employee. Second by Selectman Panasiti. Chairman Brew suggested that Mr. Rochette should forward to the Town Administrator a copy of his military pay stub so Jim can do the calculation. Everyone agreed that would be the best method. The vote was unanimous 5-0.

Selectman Panasiti moved to allow Mr. Rochette to accrue sick hours, personal hours and vacation hours during his active military leave. Second by Selectman Grella. Selectman Jensen stated that these benefits are not required by USERRA, a federal law, but by our interpretation of our town policies. The vote was unanimous 5-0.

Selectman Lyon moved to adjourn the meeting at 9:42 PM. Second by Selectman Grella. The vote was unanimous 5-0.
