- 1. Discussed outcome of the 12/19/22 Board of Selectman (BOS) Meeting.
- 2. AP raised concern about the lack of available information for the public on the petition warrant articles.

    - W&M discussed the approximately \$200K additional revenue added to the revenue budget from the state announced during the 12/19/22 BOS Meeting. Several members voiced support for use of these funds to increase COLA for town employees. Concern raised that the budget may have been cut too much this year which threatens adequate funding in future years since the BOS may be reluctant to propose a large percentage increase.
    - Consensus that, despite these concerns, the budget looks good overall and that it is too late in the process to negotiate a change with the BOS.
