2. Amherst Bicycle and Pedestrian Committee (ABPC) presentation: Chris Buchanan, Chair of the ABPC, joined the meeting to discuss warrant articles 29 and 30. The first is for \$75,000 to go into the CRF and targeted for the School Campus Path on Boston Post Rd. The second is for \$98,000 to be used for engineering work that is necessary for the committee to apply for new federal transportation grants. The work would cover a variety of work throughout the village that will coincide with planned road work.

Discussion focused on whether this should be directly in the DPW budget. If that was not possible the discussion focused on rewriting to be specific to the engineering work and money go directly into town rather than a CRF.
