

# Meeting Minutes - APPROVED July 12, 2022

1	Meeting attendees: Chris Buchanan – Chair, Wendy Rannenberg, Judy Shenk, Chris Shenk,
2	Michael Merra, Rick Katzenberg [7:10pm], Patrick Daniel (remote) and Tom Christensen
3	(remote)
4	Staff present: Kristan Patenaude – Recording Secretary (remote)
5	
6	Chris Buchanan called the meeting to order at 7:05pm. He noted that there was participation
7	from Committee members both in-person at Town Hall and remotely via Zoom.
8	
9	Wendy Rannenberg stated that four benches have arrived in Town. These will be put together
10	shortly. She will work with DPW Director Eric Slosek on placement of the approved benches.
11	She will need to discuss where to place the fourth bench with the Board of Selectmen. Plaques
12	will also be ordered for the benches.
13	
14	Tom Christensen stated that he has been riding the Amherst Street sidepath almost every day.
15	He has been collecting small amounts of trash and will analyze the amounts of this at the end
16	of his three-month ride period. He noted that someone is willing to pay for signs placed at
17	each end of the sidepath regarding not littering.
18	
19	Chris Buchanan stated that the DPW is working on small signs to place at either end of the
20	path. He will discuss these items with the DPW.
21	
22	Rick Katzenberg entered the meeting at 7:10pm.
23	
24	Chris Buchanan introduced a new member of the Committee, Michael Merra.
25	
26	Chris Buchanan stated that the multimodal counters, which will be used to count the number
27	of pedestrians and cyclists along the Amherst Street sidepath, donated by the Bean
28	Foundation, have been delivered and will be installed along the sidepath at a future date.
29	
30	1. Safe Streets and Roads for All (SS4A) Grant Program
31	Chris Buchanan explained that the grant has a deadline of September 15, 2022. The purpose is
32	uniquely aligned with the Shared Streets project in Town and is to retrofit or create
33	infrastructure for all users. He spoke with Bill Watson at the DOT and also with NRPC to
34	discuss the grant. All involved seem in agreement that the Town is aligned well for this grant.
35	Extending a sidepath from Boston Post Road to Birch Park, along with installation of a box
36	culvert, was supported by the State. The State indicated that it would send a letter of support
37	with the grant application and provide the Town resources in the grant application process.

The State noted that it believes retrofitting and rebuilding of infrastructure to pursue the
proposed Safe Streets design would be covered under the grant. The implementation portion
of this grant opportunity has a \$5M minimum project size. The Town will need to decide what

41 items to include in the application for these funds.

### • Budget discussion, Sam Fortier

Sam Fortier, civil engineer, explained that the Boston Post Road sidepath extension toward 44 45 Birch Park with a culvert to get underneath Baboosic Lake Road, is estimated to cost \$1M. Flexibility in terms of truncation of this project due to potential construction costs will be 46 47 important. The Baboosic Lake Greenway trail that extends from Amherst Street down to 48 Merrimack Road is estimated to cost \$3M. This does not include purchase of rights of way. 49 Two proposed roundabouts are indicated on the plan, one near Country Mansions and one near Wilkins School. The Amherst Village Shared Streets section's cost will vary on what the 50 51 public wants to see. The Jones Road and Mack Hill Road portion includes a painted shoulder on New Boston Road and a paved sidepath on Mack Hill Road and Jones Road to link to the 52 53 sidepath near Wilkins School. All of these projects total approximately \$12M.

55 Chris Buchanan explained that the purpose of this exercise is to produce a flexible and 56 adaptive budget plan to use for the grant application. This is not a prescription for exactly

what would happen in each section. Much of the information needed for this project will come
 out of the Village Engineering project.

In response to a question from Tom Christensen, Sam Fortier explained that construction cost,
 design engineering, construction engineering and right of way are items which will need to be

- 62 populated for the grant application.

Wendy Rannenberg stated that the potential for a new school on the Wilkins School site willneed to be taken into account.

67 Chris Buchanan noted that, if the grant is received, the Town's matching cost will be 20% of 68 the estimated costs as shown.

Sam Fortier noted that the Committee should include any long stretches where right of way is not a concern. Also, trying to save on the rail trail portion and focusing more on the proposed box culverts could be a good idea. However, connectivity to other trails is also important to consider.

Chris Buchanan explained that the Committee needs to discuss prioritizing the items to submit to the Board of Selectmen for review. If approved by the Board, the Committee can continue to pursue the grant application to submit for September. Last night, the Board awarded the bid for the Village Engineering planning item to Mobycon.

80 Sam Fortier asked about public input on the Village Streets project and how they might

81 impact the grant application. Chris Buchanan explained that he believes a grant application for

In response to a question from Mike Merra, Chris Buchanan explained that the bid awarded last night by the Board of Selectmen to Mobycon will allow for an engineering study of the Village streets which will shortly be up for reconstruction to incorporate design features that allow all users to use the space. It is based on a Shared Streets concept. This proposal will make cars the guest in the space, to allow for safer travel for all users. • Notice of Funding Opportunity review, Mike Merra Mike Merra explained that there are certain items which count toward the 20% match for the Town. These include funds in the bank, money set aside for the sidepath, and already funded in progress engineering work such as that approved for Mobycon. There are seven requirements for this match, one being Federal CFR 200.306, Cost Sharing or Matching. The Town cannot use other federal funds awarded toward the match. The match must be trackable and verifiable. The projects will need to be determined to be allowable for the grant proposal. Chris Buchanan stated that the streets in question for the Shared Streets project, and part of Amherst Street, are already in the DPW's budget and the intention is to leverage the approximately \$700,000 estimated for reconstruction of these streets toward the 20% match. These roads are already slated for reconstruction and the proposal is to use the grant funding to make them safer while leveraging the money already set aside for them. If this funding cannot be used to put toward the 20% match, the project scope will likely need to be changed. Mike Merra stated that he would reach out to DOT to get an answer on this item. He noted that volunteer services furnished by third-party professionals or consultants can be used as cost-sharing or matching. Chris Buchanan explained that the notice of funding opportunity for this grant discusses eligible items. It is unclear if a rail trail qualifies. The Federal Highway Administration has expressed that this information will be relayed if an applicant applies to the grant program. The only entities eligible to apply for the grant are those with an action plan in place. The State and NRPC believe that the Multimodal Plan is adequate for this. In response to a question from Wendy Rannenberg, Chris Buchanan explained that the bid awarded to Mobycon includes a general high-level look at the whole Village, and a more specific look at most of the proposed options the Committee is discussing this evening. Wendy Rannenberg suggested that the grant application should include the Amherst Village 126 Shared Streets project and Mack Hill/Jones Hill Road project. Chris Buchanan explained that 127 this would cost approximately \$5M and be the focus of the grant application. However, it 128 129 would be advantageous to complete a sidepath extension from Amherst Street to the Baboosic Greenway as it would include State involvement in the grant process. It is also not very 130 expensive, in terms of the other items proposed. 131 132 133 Judy Shenk stated that she believes getting the culvert near Route 101 will be a key item. 134 135 Chris Buchanan suggested that the application include the side path extension, Shared Streets project, crossings, and additional box culvert along the rail bed. The Route 101 embankment 136 issue will not be solved without federal funds or a TAP grant. The side path extension to 137 Baboosic Greenway is estimated to cost \$1.55M, the Amherst Village Shared Streets project 138 is estimated at \$4.725M, the Jones Road/Mack Hill Road loop is estimated at \$455,000; a box 139 140 culvert under Route 101 can also be included, estimated around \$675,000. The total cost for 141 these projects is estimated at \$7.125M, with a local match of \$1.425M. \$700,000 is already accounted for in the Town's budget for road reconstruction, and the remainder of the match 142 143 would be spread over seven years. 144 145 Wendy Rannenberg moved to include the sidepath extension, Amherst Village Shared Streets project, the Jones Road/Mack Hill Road loop, and the box culvert at 146 147 between Route 122/Boston Post Road in the grant application. Long term planning 164 • Ten-vear plan projects 165 Chris Buchanan explained that the State of NH has a process every other year to approve projects eligible for 80% for bike/ped infrastructure items. He has met with NRPC to review 166 167 projects previously in the 10-year plan and discuss new projects to include. He suggested including the length of the Baboosic Lake Greenway, from the Bedford town line to Birch 168 Park, down Amherst Street, with a midblock crossing, to Souhegan High School, ending at 169

170 Buck Meadow. This would be split into approximately 25 segments. All of this is currently in the Metropolitan Transportation Plan, but only one segment is currently in the 10-Year Plan. 171 This is due August 5, 2022. 172

173

174 The Committee agreed with the suggestion to request to include the Baboosic Lake Greenway 175 in the 10-Year Plan. The Board of Selectmen will be the ones submitting this request to 176 NRPC.

## • CIP Process

179 Judy Shenk agreed to help Chris Buchanan update the CIP items for the Committee.

## • FY2024 budget conversation

182 Chris Buchanan explained that last year the Committee asked the Board of Selectmen to increase the DPW's budget by \$100,000 for annual multimodal infrastructure improvements. 183 184 That funding was proposed to be used for the Village Streets project, and the Board then suggested it be placed on a warrant article for the Town to vote on. Now that the warrant 185 article has been approved, the Committee is back in the same place in terms of considering 186 187 requesting \$100,000 in the annual budget. These funds would be available every year and must be spent by June 30, 2022. This cannot be placed into an account to accumulate, so long-188 189 term projects still need to be funded by a Capital Reserve Fund (CRF). The Committee cannot 190 afford surveying, engineering, grant assistance, counters, modest improvements to crosswalks, 191 or incremental increases to annual road reconstruction projects to include modest multimodal 192 improvements. To be a sustainable organization, there must be a budget behind the case.

194 Chris Buchanan explained that funds could also come to the Committee from LUCT fund amounts, which would take money from the Conservation Commission, or from some amount 195 of car registration fees, which would also require approval through a warrant article. 196

197

198 Wendy Rannenberg stated that the Board of Selectmen likes a very lean budget. The Ways &

199 Means Committee might support this request, as it has supported requests from the Committee

200 in the past. The Town previously slashed the road budget by so much that it has needed to add

- money back into the budget over the last number of years. 201
- 202

203 Patrick Daniel asked if this request might hurt the Committee's transparency to the Town.

204 Chris Buchanan noted that this is a transparent request. This meeting, the Board of

Selectmen's meeting and Ways & Means Committee's meetings at which it will be discussed 205 206 are all public. The process of working through the budget and voting on the budget is a public,

- transparent process. 207

#### 209 Judy Shenk moved that the Committee request to the Board of Selectmen to add 210 \$100,000 to the DPW's budget for multimodal improvements. Seconded by Chris

Shenk. 211

218	Chris Buchanan stated that he would like to write a letter to Senator Shaheen thanking her for
219	selecting the Town's proposal for congressional funding. Rick Katzenberg stated that he will
220	write the letter on behalf of the Committee.
221	
222	Chris Buchanan stated that a letter should also be sent to the Bean Foundation thanking them
223	for the counters. Mike Merra agreed to help write this letter.
224	
225	4. Approval of Minutes – June 14, 2022

227	Tom Christensen moved to approve the meeting minutes of June 14, 2022, as
228	submitted. Seconded by Judy Shenk.
229	Roll Call vote: Tom Christensen – aye; Patrick Daniel – aye; Rick Katzenberg –
230	abstain; Chris Buchanan – aye; Judy Shenk – aye; Chris Shenk – aye; and Mike
231	Merra – abstain; 5-0-2, motion carried.
232	
233	Rick Katzenberg stated that he had a productive meeting today regarding combining the
234 235	Committee's plans with the SAU's plans for future development.
236	Rick Katzenberg moved to adjourn the meeting at 8:55pm. Seconded by Wendy
237	Rannenberg.
