#### **Planning Board**

On January 18<sup>th</sup>, the Planning Board held a public hearing for the newly revised town Master Plan, Envision Amherst 2035. A Master Plan is a planning document that serves to guide the overall character, physical form and development of a community. After several years of long, complex work and many hours dedicated to creating this important town document, the Master Plan was approved and will serve as a guide for all town boards and commissions. At its January 17<sup>th</sup> meeting, the Zoning Board of Adjustment approved a variance for a handicap access ramp to the front door of 158 Amherst St. within the property line's front setback.

#### January 9:

• Pursuant to RSA 32:5, I, the Board of Selectmen held a Public Hearing to take input on the proposed FY24 Town Operating Budget and proposed warrant articles. - Health insurance was renewed for town employees through NHIT guaranteeing a Not-To-Exceed renewal estimate of 9.86%.
- An update regarding the Pennichuck water line was given to the BOS
- The Selectmen approved the purchase of a used Grader in the amount of \$90k which was offset by the trade-in of the town's 37-year-old Grader. Final cost \$70k. This is an expected purchase and part of the DPW's vehicle replacement plan.
- An update on the Thornton Ferry 1 temporary bridge was presented to the Selectmen. DPW Dir. Slosek is working diligently to have this bridge installed asap.
- DPW Director Slosek provided information on a Christmas Day leak at the Baboosic Lake Community Septic. He is taking steps proactive steps to upgrade t he system and make improvements.

#### January 23:

- Congratulations to Amy Hull, the new Program Coordinator for the Recreation Dept. Amy is not new to Amherst, you may remember her from her time at PMEC. Happy to have you back!
- Amherst has another new EMT who will be joining the Fire/Rescue Department. Welcome to town, Jessica!
- The Selectmen approved the withdrawal of \$706,796 from the Amherst Fire Rescue Equipment Purchase & Repair CRF for the purchase of the 2024 Pumper Truck.

#### **Pilot Food Waste Composting Program**

The Town of Amherst is embarking on a pilot food waste program which will directly reduce the cost of tonnage that the town pays for food waste/trash removal. A reduction in cost equates to cost savings for the town. You can help by separating your food waste items and placing in a separate container and disposing at the collection point at the Amherst Transfer station.
