31 32 33 34 35 36	The cost for services from MRI is \$6,500 with a proposed time of approximately two months to present final candidates for Amherst Town Administrator to the board to review. Mr. Gould confirmed that should no acceptable candidate come from the initial search, MRI will reopen the search at no additional cost to the town. Mr. Gould also assured the board that he would personally attend finalist interviews with the Board of Selectmen.
