32	owners of lots that have bushes planted on them that are causing damage to the gravestones. The
33	Trustees feel that Lots should be cleared of overgrown bushes.

34 35	Cleaning of headstones; Cleaning of headstones cannot be done without proper certification or

37 38	Financial Reports: In the past the Cemetery Trustees have hired 1 Full time employee (FTE) and 1 Part
39	time employee (PTE), totaling 60 hours. This year it was seceded to hire 3 employees at 20 hours each.
40	Budgeting and strategic planning were also discussed.

42	Forestview Cemetery: Permitting for phase 1 of Forestview Cemetery planning; as this portion of the
43	Cemetery is less than an acre there is no permitting required. Doug Grenier of G2Plus1 will be invited to
44	the next meeting.

46	Lisa has researched the trail usage by the conservation committee and would like to have someone else
47 48	view the deed for this property to be sure that this land cannot be used by the conservation committee.
