# TOPICS OF DISCUSSION:

# 2. "Throw Back" Thursday – Amherst Heritage

Will Ludt stated that he and Conor Frain went to the New Boston Air Force Station yesterday to see the Melendy foundation. He explained that anyone who wants to go onto the base can travel with him to see the foundation. He and Conor walked Old Mack Hill Road and Brook Road that were originally part of Amherst but are now part of New Boston Air Force Station.

Lisa Montesanto stated that, 100 years ago this month, the family that lived in her house at the time lost their six-year old daughter, Alex Elizabeth Johnson, to pneumonia. The little girl was buried in Meadowview Cemetery, but Lisa Montesanto noted that she hasn't yet been able to find her grave. Lisa Montesanto and her husband bought a brick for the little girl through the Historical Society walkway project as a way to remember her.

### 3. Update on Amherst Master Plan 2020

Will Ludt explained that the Commission gave comments about the proposed Master Plan survey that will soon be produced and sent out to the public.

Nic Strong noted that the survey should be available from December 1-20, 2020. The survey will be publicized prior to being sent out. The Master Plan subcommittee may also make YouTube videos to explain the Master Plan process to the public.

Will Ludt explained that two of the Commission's comments were removed from the survey suggestions: the metal detection policy and the demolition delay as being too specific for the broad survey that has been drafted. He stated that these two items will be brought up during the Master Plan working group meetings.

#### 4. Approval of Amherst Heritage Commission's Rules of Procedure

The group reviewed the small list of changes to the document suggested by Town Counsel: a formatting error between pages 1 and 2; adding a missing section of RSA 674:44-b on page 3; and, deleting the word "strict" in two locations on page 6 with reference to compliance with RSA 91-A.

Tom Grella moved to approve the Heritage Commission's Rules of Procedure, as presented. Brenda Perry seconded.

Roll call: Will Ludt – aye; Conor Frain – aye; Brenda Perry - aye; Tom Grella – aye; and Lisa Montesanto – aye. Motion carried unanimously.

#### 5. Update on Current Budget (FY21) and Planned Budget (FY22)

Will Ludt stated that the Commission's FY21 budget was \$2,572. The proposed FY22 budget has a small increase, totaling \$2,608. The Commission reviewed the proposed budget numbers.

# 6. Potential CLG Grant Submittal

November 12, 2020 APPROVED

Will Ludt explained that he has submitted a letter of intent to the NH Division of Historical Resources for their CLG Grant. The proposed project, totaling approximately \$5,000-6,500, is to digitize QR codes and create signage for high priority heritage resource sites in Town. This would also allow for an updated map on the Town website, built with the QR code signs in mind. The intention of this project is to improve the public's access to Amherst heritage sites. He explained that the Commission would partner with NRPC for the technology integration. The primary goal is to get the Town's heritage data out of paper and into the hands of the public to enhance their knowledge.

Conor Frain noted that some of the targeted sites for this project are the Town Beach, the Baboosic Lake rail station, the corn crib, Town Hall/cemetery, PMEC Sawyer Cottage, Robert Frost house on Boston Post Road, bridge across the Souhegan River on Route 122, Jones Road, and the Route 122 rail station.

Will Ludt also noted that the Souhegan Valley Rail Trail non-profit organization is looking to create a 16.5-mile rail/trail bike path along the railbed that runs from Wilton to downtown Nashua.

### 7. Update on Potential Black History Event with NBAFS – January 2021

Will Ludt explained that there is a proposed walk in January/February with the NBAFS for Black History Month. A group would meet at PMEC, walk up Brook Road to the gate at the base, up Old Brook Road and to the Melendy foundation. There could be about 50 people on this walk and social distancing would be followed.

#### 8. Update on Outbuilding at Corn Crib

Will Ludt explained that the ACC approached the Heritage Commission about 6-7 months ago regarding the status of the second building on the corn crib site. A certified archaeologist came to measure and document the building. The building itself is in bad shape. He will send a copy of the archaeologist's recommendation to the group.

In response to a question from Conor Frain, Will Ludt stated that it is unclear who owns the land that the building is on. The tax records make it look as though the Town owns the property and easement that the building is on. A gentleman near the site doesn't agree with this assessment though.

# 9. Minutes: 8 October 2020

Conor Frain moved to approve the minutes of October 8, 2020, as written. Lisa Montesanto seconded.
