G. Leedy will distribute Word 25 documents to the Board for their use in review of the draft. 26 27 G. Leedy discussed two on-going efforts to address zoning changes for next year. The first is the Route 28 101 Mixed Use zoning. We may want to look at expanding the mixed use concept to other areas of 29 town. The committee looking at this is Cliff, Rich and Marilyn. We will get together once Marilyn is back. 30 31 The second effort is a rewrite of the sign ordinance. Gordon suggested putting together a committee 32 with two members of the Board, two business owners and a sign company representative. Gordon will 33 contact the Chamber of Commerce to see who may be interested in participating. Peter Lyon and Cliff 34 agreed to represent the Planning Board.
