II. Proposed 2021 Warrant Article

The proposed 2021 warrant article to establish the "Amherst Multimodal Facilities Capital Reserve Fund" and place in it \$75,000 for the Boston Post Road School Campus Sidepath was presented to the Board of Selectmen on October 26th, 2020.

- Presented to Ways & Means on November 23rd
- Ways & Means and BOS to vote on supporting/not-supporting warrant articles soon
- BPAC needs to start planning how to communicate the concepts of the warrant article to the public
