I. Transportation Alternatives Program (TAP)

A. Souhegan Valley Rail Trail

CSX officially filed to purchase Pan Am on February 26, 2021. Public input period lasts 60 days until April 26, 2021 to suggest prospect of rail trail inclusion within railroad right of way.

E. "Public Trails on Private Land" effort

F. Bridge over Souhegan River (Private Fundraising or CMAQ Opportunity)

If the funding of the Boston Post Road School Campus project is successful, this phase of the northern end of the project is expected to terminate at the Scott Conservation Land, south of the Souhegan River. Multimodal facilities across the existing bridge are lacking and modifying the existing bridge to accommodate multimodal users is not possible. Estimates from bridge manufacturers estimate that a multimodal crossing of the Souhegan River can be built for approximately \$325,000.

G. Municipal Portion of NHDOT Ten Year Plan Project (Private Fundraising Opportunity)

NHDOT project 42593 to rehabilitate a portion of the abandoned B&M rail bed, the requires \$170,513 to be raised by the Town of Amherst by 2026 to access \$852,566 of state funding. The sooner this money is raised, the chances of moving the project earlier in the schedule increase.
