Board of Selectmen Meeting Highlights

February 6:

- Congratulations to Mark Bender on his appointment as an Alternate to the Conservation Commission!
- Welcome to Cameron as a part-time dispatcher to the Public Safety Communications Center
- the BOS authorized the purchase of a Ford 550 truck for DPW; the purchase is part of the DPW vehicle replacement plan and replaces a 2011 truck
- the BOS agreed to reduce a Comstar invoice by \$720 upon recommendation and determination of need
- the BOS aproved the Finance Dir. to hire an assistant for the department; this follows the inability of the town to find a qualified Assistant Finance Dir., as previously approved
- the Amherst Junior Women's Club was approved for the use of the Town Green for the annual Easter Egg Hunt
- a Hawker and Peddler's License was approved for Samich, LLC

February 21:

- the Town has engaged the law firm of Drummond Woodsum as new town counsel
- the focused site investigation of PFAS in the fire station area has been completed and sent to NHDES for their review
- a proposed updated town employee sick leave policy was discussed and will be further evaluated
- Finance Dir. updated the Selectmen as to current budget to actual status
- Job descriptions for Fire Rescue Deputy Chief of Operations and Deputy Chief of Prevention were updated
- BOS approved the repair of the damage at the Recreation Dept office (burst pipes)
- BOS approved the removal of a pine tree in the Common due to extensive rot (recommended by tree warden and contractor)
- Atlas Fireworks was given approval for retail sales

Pilot Food Waste Composting Program

The Town of Amherst has embarked on a pilot food waste program which will directly reduce the cost of tonnage that the town pays for food waste/trash removal. A reduction in cost equates to cost savings for the town. You can help by separating your food waste items and placing in a separate container and disposing at the collection point at the Amherst Transfer station.


