




Proposed Warrant Article

Article X1: Amherst Multimodal Facilities Capital Reserve Fund.

To see if the Town will vote to establish a capital reserve fund under RSA 35:1 known as the "Amherst Multimodal Facilities Capital Reserve Fund" for the purpose of making multimodal capital improvements within the town including but not limited to capital construction to support alternative transportation and to provide matching funds for state, federal and private grant programs, and to raise and appropriate the sum of seventy-five thousand dollars (\$75,000) to be added to this fund, so established, and further, the Select Board shall be named agents of the fund and be authorized to make expenditures from the fund.

Proposed Warrant Article: Objectives

- Establish a capital reserve fund as an infrastructure funding mechanism
- Would allow the town, and board of selectmen as agents of the fund, to:
 - Fund specific projects (by warrant article or other means)
 - Seize cost effective opportunities for said projects

AND

- Raise \$75,000 to capital reserve fund to pursue the <u>Boston Post Road school</u> <u>campus sidepath</u> project
 - Raises 1/3 estimated project cost
 - Creates possibility to fund entire project in 2021 with 80% federal grant
 - Does not preclude us from grant project eligibility





Municipal Roads by Volume




Project Cost & Savings Opportunities

BOSTON POST ROAD SCHOOL CAMPUS SIDEPATH PROJECT

Estimated Project Cost

- Estimated \$225,000
- Approximately 4,000 feet of sidepath at \$56.25/linear foot
 - Surveying
 - Engineering
 - Water Crossing
 - Possible right-of-way constraints
 - Likely need for some grade separation
 - Crossing enhancements


Project Comparison



Transportation Alternative Program (TAP) Grant


- Occurs at most, every 2 years last occurrence was in 2018
- Replaced Safe Routes to School, Recreational Trails, Transportation Enhancement, and Scenic and Cultural Byways grants
- Likely to occur in 2021
- 80% federal funding / 20% local match
- Project minimum thresholds
 - Varies
 - In 2018: \$400,000 minimum project cost
- Town of Amherst applied for the TAP grant in 2018 but was rejected as the Town did not have the 20% already raised

Leveraging grant funding to maximize opportunity




Leveraging grant funding to maximize opportunity

80% Grant Portion (\$320,000)


