LM in consultation with the Selectman and the Town Finance Director recommended moving \$500,000 of cash in the Capital Reserve funds to a 6 month CD.

RG motioned to move the cash to a 6 month CD, MP seconded. All voted to approve.

7. SAU 39 requested \$2,000 from the Isaac Spaulding Trust for expenses incurred in support of teacher training and enrichment.

All appropriate paper work was submitted and reviewed. RG motioned to approve the payment. LM seconded. All voted to approve.
