- 4. Cambridge Trust Investment Report:
  - a. LD reviewed continued Covid impacts, inflation impacts, and general market performance metrics. The performance of the investment portfolio was reviewed in detail. A copy of the full report is available at Town Hall.
- 5. Capital Reserve Funds (CRF) investment discussion:
  - a. JD provided insights on behalf of the Board of Selectmen into the town's planned expenses that will impact CRF balances.
  - b. LM will schedule a time to review with the SAU their anticipated spending needs that will impact CRF balances.
  - c. The Trustees requested that Cambridge invest \$1MM of the current cash holdings into either a CD or Treasury, with a max term of 1 year, at the best going rate. LD and JN will review options and report back to the Trustees.
- 6. Trust & CRF Deposits & Withdrawals:
  - a. The Amherst, NH Trustees of the Trust Funds voted to authorize the withdrawal of the following amounts from the Cemetery Expendable Trust in accordance with the trust funds requirements to support work done at both Meadowview and Forestview cemeteries:
    - i. \$468.00 (fencing at Forestview)
    - ii. \$711.07 (plants and planting materials at Meadowview)
    - iii. \$985.32 (seed at Forestview)
  - b. The Amherst, NH Trustees of the Trust Funds voted to authorize the withdrawal of \$29,953.53 in the following amounts to reimburse the Town of Amherst for expenses incurred in support of annual cemetery maintenance:
    - i. \$1000.00 (Alice Wilkins Trust Fund)
    - ii. \$1000.00 (George Putnam Trust Fund)
    - iii. \$8,051.08 (Perpetual Care Trust Fund)
    - iv. \$19,902.45 (Cemetery Expendable Trust)
