- 1. The meeting was called to order at 6:05pm by LM.
- 2. Public Comments None
- 3. Cambridge Trust Investment Report: Below are some key highlights from LD's review. A copy of the full report is available at Town Hall.
 - a. The U.S. is in the late cycle expansion phase with rising but moderate recession risk.
 - b. The Federal Reserve raised interest rates in 2022 to the highest level since December 2007. It is expected the Federal Reserve will raise rates an additional 0.75% in 2023.
 - c. Reviewed Fed Funds rate expectations for 2023 as it is expected to raise rates.
 - d. Reviewed 10-year forward return projections for both equities and fixed income.
 - e. Reviewed the performance of the investment portfolio to the stated benchmarks within the Investment Policy Statement.
- 4. Capital Reserve Funds (CRF) investment discussion:
 - a. School & Town expenditure plans:
 - i. A review of planned spending was discussed relative to available funds, which will guide future investment planning.
 - b. Investment Planning Discussion:
 - i. Trustees directed the Bank to invest \$500M of the Capital Reserve Fund in a 12-month CD.
 - ii. Trustees directed the Bank to invest \$500M of the Capital Reserve Fund in a 24-month CD
 - iii. Trustees directed the Bank to invest \$300M of the Common Fund in two 12month CDs
 - iv. Trustees directed the Bank to maintain the remaining funds, approximately \$1MM, in cash assets.
- 5. The Trustees reviewed and approved the Amherst Board of Selectman request for \$706,709.08 to be withdrawn from the Amherst Fire Rescue Vehicle & Equipment Purchase and Repair CRF. BG motioned to approve the withdrawal request; DS seconded. All voted in favor.
- 6. Cemetery Trust Withdrawal Request:
 - a. The Trustees reviewed and approved the Cemetery Trustees request for \$16,309.89, to be withdrawn from the Cemetery Perpetual Care Trust Fund. BG motioned to approve the withdrawal request; DS seconded. All voted in favor.
