 - a. Six proposals received and reviewed by the committee on May 5th and June 9th 2016 Two from the Heritage Commission, one from Cemetery Trusts, one from Amherst Land Trust, one from the Piscataquog Land Conservancy, which was later rescinded, one from the Amherst Fire Rescue.

 - i. \$63,000 awarded to AFR for purchase of 2 LUCAS devices (automatic CPR)
 - ii. \$8,915 awarded to Heritage Commission for Town Hall Vault historical documents preservation and conservation project. A plaque will be placed outside the vault renaming it the "Bertha Rogers Archives."
 - iii. Checks received by Town Hall
- 8. Capital Reserve Inventory Review R Grunbeck
 - a. RG was unable to attend the trustee meeting. He is waiting on additional information from, and will then email a draft of the Capital Reserves Inventory document to the trustees for review, comment, approval.
