All present approved, with RG having previously given approval per LM.
- 7. Trust Funds Investment Review: Cambridge Trust
 - a. The Trustees signed approved Investment Policy documents for FY19
 - b. There were no changes from the prior year
 - c. Investment Trust Review
 - i. Common Trust Fund has seen a 5% YTD gain through September
 - ii. It has matched or outperformed its benchmarks in short-term returns (3 mo. 3 yr), and has been very close in performance vs benchmarks since inception
 - iii. Page 15 Communications Services new sector in the S&P 500
 - iv. Capital Reserves Fund the Federal Reserve increased the Fed Funds rate in September and will again in December; this drove the portfolio yield up to 1.88%

Lori,

I have been working with the Cemetery Trustees and our Finance Department to try and streamline how we pay vendors who do work for the Cemetery Trustees. Two top level objectives here are to get Cemetery vendors paid more quickly and to make sure that the vendor only gets paid once. The proposed process outlined below places a small risk on the Town if the Town were to make a payment on behalf of the Cemetery Trustees and the TotTF do not approve the Trust Fund withdrawal, but I don't view this as a substantial risk.

After talking to the Cemetery Trustees and our Finance Department, I would like to get your thoughts on the following:

- The Cemetery Trustees meet and approve the Town paying a vendor who has provided services for the Cemetery Trustees.
- The Cemetery Trustees meet and approve a Trust Fund withdrawal request to the Town to cover the payment to the vendor who has provided services for the Cemetery Trustees.
- 3. The Cemetery Trustees will submit both 1 and 2 to the Finance Department
- 4. The Finance Department, after making sure that both 1 and 2 are in order, will pay the vendor in step 1 using the normal approval process and submit the Trust Fund withdrawal request to the TotTF.
- After the TotTF approve the Trust Fund withdrawal, the TotTF / Cambridge Trust will send a check payable to the Town of Amherst to the Finance Department to cover the payment to the vendor who has provided services for the Cemetery Trustees in step 1.
