- 4. Trust Fund Investment Review. Maureen Kelleher reviewed Investment performance for the 3rd quarter. Overall the Common Trust funds were up 1.13% for the 3rd Quarter and 14.62% YTD.
 - a. The TotF asked numerous questions on the portfolio.
 - b. A Full copy of the performance is on file at Amherst Town Hall.
 - c. The ToTF discussed potential Cash needs for the Town of Amherst, ASD and SHS after consulting with the various town boards. The following guidelines were given to Cambridge Savings Bank:
 - i. RG made a motion to instruct Cambridge Savings to invest up to \$650,000 of the Capital reserve funds in appropriate instruments with a maturity date of up to 18 Months. BD seconded. All approved
 - ii. RG made a motion to instruct Cambridge Savings to invest up to \$200,000 of the cash in the Common Trust funds in appropriate instruments with a maturity date of up to 6 Months. BD seconded. All approved
- 5. Annual Investment Policy Review: The ToTF discussed the current policy. Two changes were discussed
 - a. III:A: The Trustees change the last sentence to read:
 - i. The Investment advisory agreement shall be reviewed and put out to bid at the discretion of the ToTF.
 - b. II:A:7 The ToTF added item # 7: No single individual stock holding will exceed 5% of the equity portfolio.

RG made the motion, DL seconded. All voted in favor.

- 6. Town of Amherst
 - a. LM presented a request from the Board of Selectmen (BOS) for \$31,624.40 from the Town of Amherst Library Renovation Capital Reserve Fund.
 - i. The request was submitted with all appropriate supporting documents.
 - ii. RG motion to approve, LM second. All voted to approve.
 - b. LM presented a request from the Cemetery Trustees for \$23,007.14 to be paid to the Town of Amherst for FY 19 annual costs: The Breakdown of the request is as follows:
