- 1. Meeting minutes from the October 30, 2014 and January, 07, 2015 Trustees of the Trust Fund meeting were approved by the Trustees.
- 2. Torrey Demanche, Executive Assistant on behalf of Jim O'Mara, Town Administrator. The trustees reviewed and authorized the withdrawal of specified amounts from the funds listed below.
  - a. Communication Fund Capital Reserve Withdrawal Request in the amount of \$22,138.21 for radio communications contract to Two-Way Communications.
  - b. Communications Center Capital Reserve Fund withdrawal request in the amount of \$3, 674.69 for purchase of replacement back-up dispatch radio.
  - c. Communications Center Capital Reserve Fund withdrawal request in the amount of \$4,252.80 for a three (3) year extension of the Horizon Global Advanced Replacement Warranty for Amherst's radio tower microwave equipment.
- 3. Review of Trust Funds. Maureen Kelliher of Cambridge Trust presented the "Investment Management Review for the Town of Amherst, January 22, 2015." A copy of which is available at the Amherst Town Hall.
  - a. Wealth Management Presentation, City of Amherst included the market outlook (price of oil, U.S. vs. global economy), global growth, and forecasted returns.
  - b. Common Trust Fund Asset Allocation, Page 18. Discussed the cash position of several funds to be spent by the associated trusts as intended, or to be reinvested with the goal of improving income generation and capital appreciation. Identified the trusts with significant amounts of cash investments, and developed a follow-up plan with the fund trustees regarding the spending or reinvestment of funds.
